The Association shall return the deposit to the Owner, contractor or subcontractor within fifteen (15) days following completion of the project provided no damage is caused to the Common Areas or Association Property. If damage is caused by the Owner, contractor or subcontractors, the Association shall use the funds to repair the damage and return the remainder, if any. If the security deposit is insufficient to cover the cost to repair the damage, then the Owner shall be liable for the excess cost and shall pay the Association all additional amounts required within 15 days of demand.
